**AP\* English Literature and Composition**

AP English Literature and Composition is designed for teachers who have never taught in this program. It can also be beneficial to teachers who have had some experience teaching AP classes but who would like ideas for new instructional strategies, and for teachers working with honors classes that students take as prerequisites to AP classes. Participants will work in two roles during the institute: (1) as teachers to develop techniques and curriculum appropriate for Advanced Placement students and (2) as students to stimulate their own thinking processes. Participants will receive numerous text books and teaching materials.

Dr. Rebecca Daniel is an experienced AP English Literature/Language and Composition teacher and College Board\* certified consultant. Her doctoral studies focused on how to establish authentic voice in response to literature for Advanced Placement English students. She was an AP Lit Exam reader for fourteen years, has written materials for College Board publications, has done multiple presentations at the College Board's Advanced Placement National Conference, and participates in the College Board Coaching/Mentoring program. Following instruction in teacher institutes, she offers ongoing contact via e-mail as participants work to implement strategies developed during the sessions. She is a proud West Virginian. Becky has been with Wright State University's Advanced Placement Summer Institute each year since 2006.

**AP\* BIOLOGY**  
**July 9 - 12, 2013 (4 days)**

Participants in the AP Biology AP Summer Institute will have the opportunity to perform and or review all of the labs in the New AP Biology Lab Manual. We will also discuss how to tweak your labs to make them student driven and we will share best practices and hints on what works in the AP Biology classroom to improve student achievement. I will share my approach to teaching AP Biology in detail – including an emphasis on student’s modeling their understanding. During the week will discuss textbooks, syllabi, the 2013 exam FRQ’s and rubrics, equipment and other details of the course. Please bring a copy of your textbook and your current syllabus if you are teaching AP Biology. It is my intention to spend at least one half day developing your syllabus, but may increase this block of time if participants wish this to be a focus. You will utilize a four function calculator and some participants have found it useful to photograph lab setups. A lap top for note taking and use in internet activities is recommended. I will email you suggesting documents to download so we can use them during this week as well as details concerning the AP Summer Institute as they evolve. Traditionally, participants receive several text books and materials donated by supply companies.

Mr. Smanik is a national board certified science teacher and coach at Sycamore High School in Cincinnati, Ohio. He has over 25 years of teaching experience, 16 as an AP Biology instructor. He has experience teaching all levels of Biology as well as physics, chemistry, anatomy and physiology, and earth science. He was the head cross country coach and track coach at his high school for 10 years and has coached basketball at all levels for 24 years. Jim has been an AP Biology reader for 14 years, approximately 9 of those as a Table Leader. He has been a consultant for the College Board since 2000 and has presented over 20 one day workshops; over 20 week long APSI’s; and piloted labs for the redesigned AP Biology lab manual as well as for the new AP Biology lab kits for Carolina. Jim is presently working on AP innovations and professional development review for the College Board. Jim is completing his second year as a member of the Developmental Committee (DC) (formally called test development) for the New AP Biology exam. He lives in Maineville, OH with his wife Susan and two daughters Lauren and Katie. This will be Jim’s fourth APSI with Wright State University.
